TEMPORARY/NON-RESIDENT LICENSURE OR CERTIFICATION**

Arkansas Law provides for the temporary registration of non-resident appraisers who are currently certified or licensed in other jurisdictions, provided those states have not been held in non-compliance by the Appraisal Subcommittee of the Federal Financial Institutions Council and are deemed to have substantially equivalent licensing certification requirements.

To receive a temporary or non-resident license or certification, an applicant must complete and notarize the requested information and attach supporting documentation from the state in which the applicant is licensed or certified as an appraiser. Please enclose a check or money order in the amount of **\$150** for **Temporary** licenses, or **\$325** for **non-resident** license/certification fees.
