CALL TO ORDER

The meeting was called to order by Dr. Ryan Collins, President, at 12:30 p.m.

ROLL CALL

Board Members present: Dr. Terry Barnett, Dr. Beverly Foster, Mr. Jack McCoy, and Dr. Tom Taylor.

Board Members absent: Dr. V. Savelle Barnes and Mr. Weldon Roberts. Mr. Roberts' absence is excused because of medical reasons.

Staff Members present: Ms. Rebecca Wright, Executive Director.

Guests Present: Kendra Booth of Blue Cross Blue Shield and Becca Drew of Attorney Pat James' office.

Transcription of Minutes

Dr. Collins thanked Dr. Foster and Ms. Abernethy for reminding that this information must be discussed in a public board meeting and that a poll vote cannot be taken outside of a public meeting.

At the July 22, 2010, Board meeting, the Board voted to have the June 10, 2010, Board meeting minutes transcribed. Dr. Collins stated that since the July meeting, Ms. Rebecca Wright obtained a cost estimate for transcription of the minutes. The estimate is \$600 - \$800. Dr. Collins asked the Board if they would like to continue with the transcription of the minutes or if they had other ideas.

Dr. Tom Taylor stated that the way the minutes are written has been working. He thought the June 10, 2010, minutes needed amendments. Dr. Taylor suggested that draft minutes could be mailed to the Board members before the Board meeting. Dr. Collins stated that the minutes could be drafted and sent to the Board members and the members could provide amendments to the Board office and a new draft could be made.

Mr. Jack McCoy stated that this idea does not alleviate the problem. He stated that he a motion was made to correct the minutes and he would like to have the minutes be correct when they are written.

Dr. Taylor moved to not have the minutes transcribed because of the estimated cost. Dr. Terry Barnett seconded the motion. Discussion followed. A roll call vote was taken. Dr. Barnett and Dr.

Taylor voted yes. Dr. Beverly Foster and Mr. McCoy voted no. Dr. Collins broke the tie. He voted yes. The motion passed.

Dr. Collins stated that the Board office will send out to the Board members a draft of the June 10, 2010, minutes with amendments included. He stated that from this point, draft minutes will be sent out to the Board members before the next meeting and the members will provide any amendments to the Board office, and a new draft will be written that includes the amendment requests.

Dr. Collins verified that Mr. McCoy's address on file was correct. The address is correct. Dr. Collins verified that Dr. Foster's fax number on file was correct. Dr. Foster stated that she has not received some faxes. Dr. Collins stated that the Board office will also follow up with mail to Dr. Foster to ensure that she receives information from the Board office.
