Consent Order approval

During the Board's December 10th meeting it was decided that a consent order be drafted for approval regarding Dr. Philip Roberts' felony conviction. The consent order was drafted and forwarded to all the board members for review. This teleconference was called in order to vote on the drafted consent order. Dr. Butler made a motion to approve the consent order and send it to Dr. Roberts. Mr. McCoy and Mr. Gunter simultaneously seconded the motion. All those who were in favor of the motion were Dr. Butler, Dr. Courtney, Mr. Gunter, Dr. Heard, and Mr. McCoy. Not in favor of the motion was Dr. Taylor. Motion passed by majority.

Regarding Dr. Roberts 2016 license renewal application, the Board discussed whether or not it should be approved or denied. Mr. McCoy made a motion to deny Dr. Roberts' renewal and return it to him. Dr. Butler seconded the motion. All those who were in favor of the motion were Dr. Butler, Dr. Courtney, Mr. Gunter, Dr. Heard, and Mr. McCoy. Dr. Taylor abstained. The motion passed by majority.

Temporary License Request

The Board overlooked a temporary license request at the credentials review on 12/10/15. Timothy Chad Bryant had applied for a supervised temporary license along with his credentials application. His credentials were approved at the 12/10/15 meeting but no motion was made on his temporary license application. After considering Mr. Bryant's temporary license application Dr. Courtney made the motion to approve his request. The motion was seconded by Dr. Butler. Motion passed unanimously.
