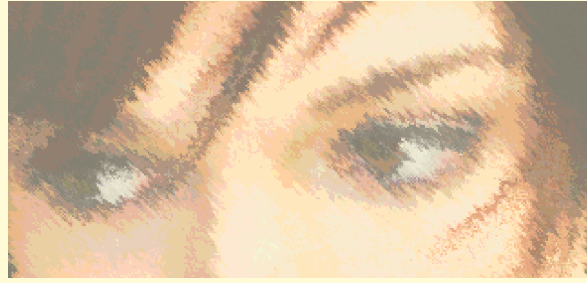

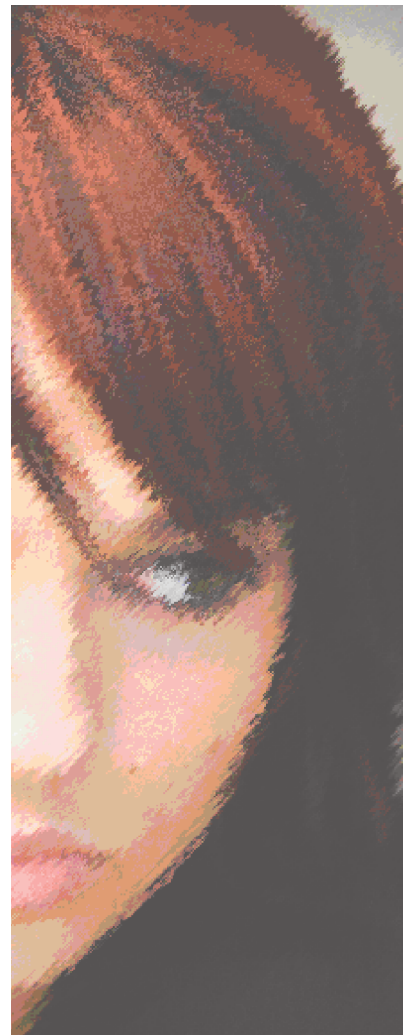

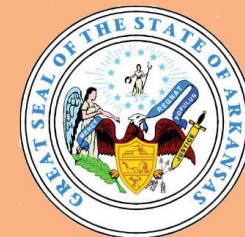

We are working with ADH to develop an on-line licensing program and will keep you posted. Please use the form in this newsletter to request license renewal.

To Renew A Practitioner License

- Complete and submit renewal form
- Submit a check or money order for \$100. (A \$50 late fee will apply if renewal is postmarked 30 days after expiration date.)

Lifetime License

- Lifetime license requirements are age 65 and 30 years as a licensed cosmetologist and a one time fee of \$50. License must be current through 2010 to be eligible.

Salon Renewal - December 31st!

- To renew a salon license for a one or two year period please complete and submit renewal form.
- Submit a check for \$100 for one year or \$200 for two years. (A late fee will apply if renewal is postmarked 30 days after the expiration date.)
