There following incidents occurred during the examinations this month:

- During the morning cosmetology exam on September 11, the staff, examiners and candidates found profanities written on the outside windows. Maintenance was called and they promptly removed it.
- During the morning cosmetology exam on September 11, candidate A-7 requested to go to the restroom and was properly escorted by Ms. Thornton. The candidate returned to the exam facility and continued with the exam.
- During the afternoon cosmetology exam on September 11, A-7's curling iron broke during the exam.

- During the afternoon cosmetology exam on September 12, 2006, A-6 failed to bring a supply of water for the exam.
- During the afternoon manicure exam on September 12, 2006, B-1 and B-2 appeared confused during the exam. B-1 unplugged her curling iron and put up her mannequin. The instructions were read to them again, and they continued the exam.
- During the afternoon cosmetology exam on September 12, 2006, B-1 set up for the hair coloring phase of the exam instead of the chemical relaxing.
