- During the afternoon cosmetology exam on June 12, A-1 cut herself while coming the mannequin for chemical waving. She followed the proper blood spill procedures before continuing with the chemical waving phase. Cosmetology inspector Rose Horner completed the incident report.

- During the afternoon cosmetology exam on June 12, B-6 cut herself. She immediately informed the examiner and followed proper blood spill procedures before continuing with the haircut. Cosmetology inspectors Rose Horner and Lavonne Green completed the incident report.
- During the first instructor exam on June 18, the candidate reversed the order of presenting the theory and demonstration phases. The examiners erred on the candidate's side by reversing the scoring of the phases. Cosmetology inspectors Brenda Morgan and Pat Jackson did not complete an incident report on this situation but were instructed by Director Wittum to document its occurrence after the office received a call from the candidate's school questioning why the candidate was not given the proper time allotted for the exam.
