Page 6 of 12; 1.18 DELIVERY: FOB DESTINATION should read as follows:

1.18 DELIVERY: FOB DESTINATION: The agency requests delivery of materials within thirty (30) calendar days after all approvals of the successful vendor's design submittals, drawings and fabrications have been satisfied.

If this delivery date cannot be met, the bidder must state the number of days required to place the commodity in the ordering agency's designated location. Failure to state the delivery time obligates the bidder to complete delivery by the agency's requested date. Extended delivery dates may be considered when in the best interest of the state.

Delivery _____ calendar days after all approvals of the successful vendor's design submittals, drawings and fabrications have been satisfied.

The vendor shall give the agency immediate notice of any anticipated delays that will affect the delivery requirement.

Loss or damage that occurs during shipping, prior to the order being received by the agency, is the vendor's responsibility. All orders should be properly packaged to prevent damage during shipping.
