Responses received after the designated bid opening date and time <b>shall</b> be considered late and <b>shall</b> be returned to the vendor without further review. . It is not necessary to return “no bids” to OSP.			

**New Language**

SUBMISSION DEADLINE FOR RESPONSE			
<b>Bid Opening Date:</b>	March 17, 2017	<b>Bid Due Time:</b> <b>Bid Opening Time:</b>	12:00 noon Central Time 2:00 p.m. Central Time
Responses <b>shall not</b> be accepted after the designated bid due date and time. In accordance with Arkansas Procurement Laws and Rules, it is the responsible of vendors to submit responses at the designated location on or before the bid due date and time. Responses received after the designated bid due date and time <b>shall</b> be considered late and <b>shall</b> be returned to the vendor without further review. <b>NOTE: Bid due time and bid opening time are different.</b> It is not necessary to return “no bids” to OSP.			

2) Section 1, 1.7, A, #1

Reference to "bid opening date and time" is changed to "bid due date and time".

Section 1, 1.9, D

Reference to "bid opening" is changed to "bid due date and time"

This change by virtue of this addendum become a permanent addition to the above referenced RFQ.
