1. **Scope:** All eligible purchasers within the State of Arkansas including local public procurement units are authorized to purchase products and services under the terms and conditions of this price agreement.
2. **Changes:** Payments shall be submitted to the contractor at the address shown on the invoice. Payment shall be tendered to the contractor within thirty (30) days of the date of invoice. After the sixtieth (60) day from the date of the invoice unless mutually agreed to, interest shall be paid on the unpaid balance due to the contractor at a rate of one half of one percent per month in accordance with Arkansas Code Annotated § 19-11-224. The procuring agency shall make a good-faith effort to pay within thirty (30) days after date of invoice.

Records relevant to Purchasing Entity transactions shall be subject to examination by appropriate government authorities for a period of five years from the date of acceptance of the purchase order.

Reports shall be listed by state location, name of the ordering entity, quantity purchased, unit price, and the total dollar amount sold.

Usage Reports shall be delivered to the State of Arkansas, Office of State Procurement, 1509 West 7<sup>th</sup> Street, Little Rock, Arkansas 72201 (Attention: Judy Shirley) within ~~fifteen (15)~~ thirty (30) calendar days upon completion of performance quarterly periods cited in the paragraph below. Contract quarterly reporting periods shall be:

July 1 through September 30	due October <del>15</del> <u>30</u>
October 1 – December 31	due January <del>15</del> <u>30</u>
