### AVAILABILITY OF FUNDS NOTICE Prevention Resource Center Sub-Grant Program

The Arkansas Department of Human Service’s Office of Alcohol and Drug Abuse Prevention (ADAP) announces availability of funds in the amount of \$1,452,480 to support the Prevention Resource Center sub-grant for approximately thirteen (13) regional awards of varying amounts, The purpose is to host the Regional Prevention Resource Center for capacity development of local communities to address substance abuse issues. The source of the funds is 100% federal from the Substance Abuse Prevention and Treatment Block Grant.

These funds are to support sub-grants for the first budget year of a three-year period. Future year funding is contingent upon progress achieved and availability of funds. An annual non-competitive continuation application is required for the 02 and 03 year. Eligible applicants are any of the following: a charitable or faith-based agency, local unit of government, public and/or private non-profit, 501 (c) 3 service agency or school. Grantees will be selected on a competitive basis.

Applications must be received by ADAP no later than 4:30 p.m. on **October 21, 2009** at DHS/DBHS, Office of Alcohol and Drug Abuse Prevention, 305 S. Palm, Little Rock, AR 72205 (**United States Postal Service**) or 4800 W. 7<sup>th</sup> Street, Little Rock, AR (**Shipping/Hand Delivery**). Applications meeting technical requirements and passing the Peer Review process will be reviewed by the Arkansas Alcohol and Drug Abuse Coordinating Council’s Treatment/Prevention Committee on or about January 12, 2010. The Coordinating Council will make final funding decisions during their January meeting.

An Application Development Workshop is scheduled for 10:00 a.m. on September 23, 2009. The purpose of the workshop is to review grant requirements. Please bring a copy of the Request for Application (RFA) with you. The RFA **will not** be available at the workshop. ALL interested applicants are encouraged to attend.
