AGENDA ITEM 1 – ACTION: Recommendation to the Governor on the Certification of Local Workforce Development Boards

RECOMMENDATION: It is recommended that the Executive Committee of the Arkansas Workforce Development Board recommend certification to the Governor of the Eastern, Southeast, and Western local workforce development boards.

INFORMATION/RATIONALE: Per board policy, local workforce development boards have until July 31, 2015 to submit requests for certification by demonstrating that they meet the membership requirements as outlined in the federal and state Workforce Innovation and Opportunity Act laws.

Seven local workforce development boards were reviewed by the Arkansas Workforce Development Board on July 21 and recommended for certification to the Governor. The remaining three local workforce development boards have submitted certification requests and their corresponding certification documents are attached for consideration.

Staff have reviewed the certification requests and determined that the Eastern, Southeast, and Western local workforce development boards have members appointed in all required membership categories.
